

Caring and sharing- that's the philosophy of the Escapees RV Club.

Members are expected to conduct themselves respectfully and with consideration for others. We are a decades-old family of RVers. Unfortunately, even the closest families don't always get along. To help prevent and manage conflicts, we have established a code of conduct for our members. Members may be subject to suspension or termination of membership for any of, but not limited to, the following reasons.

- Discrimination is not acceptable and will not be tolerated. This includes discrimination based on sex, race, color, nationality, ethnic or national origin, ancestry, citizenship, religion or belief, age, physical or mental disability, medical condition, sexual orientation, veteran status, marital status, genetic information or characteristics.
- Members are expected to refrain from displays of violent or abusive behavior, and to maintain control
 of their temper, when around other members, guests, and staff at any Escapees park or event. This also
 applies in our Escapees-managed online platforms, including our discussion forum, RVNetwork.com, and
 our social media profiles and groups.
- Use of profane language or any behavior that is unsolicited, unwanted, and deemed harassment of a member, guest, or staff of the Escapees RV Club, at any Escapees park or at any Escapees event.
- Delinquency, nonpayment of fees, dues, charges, or other financial obligations owed to the Escapees RV Club or any of the Escapees parks. Nonpayment of fees includes unpaid returned-check charges and bank processing fees that are not remitted upon request
- Members are expected to follow park rules while staying at a Rainbow Park/Escapees RV Park, a SKP Co-Op park, or any private park in our discount network. Additionally, members are expected to follow rules while attending Escapees events. This includes those set by the organizers and the venue or property where the event is taking place. We strongly recommend that members review and adhere to the industry-sanctioned Good Neighbor Policy and the RVers Boondocking Policy.
- Members should follow all reasonable requests made by park management or staff at any Escapees facility or function.
- Members should not infringe on the copyrights of, spread harmful, misleading or defaming information about others or Escapees.
- Members should refrain from discussions regarding religion, politics or other controversial topics
 during events, activities, facilities, functions or online communication platforms and groups bearing the
 Escapees name that may cause conflict with others. Our spaces should remain respectful and welcoming. There are several BoF groups within Escapees targeting specific sets of beliefs that we welcome you
 to join for discussion.
- Out of respect for privacy, members are not permitted to use information in the membership directory
 for personal gain. In addition, members are not permitted to make promotional posts or send unsolicited messages to members of our social media pages or groups. This includes chain letters, multi-level
 marketing, advertising and promoting other products or services.

Members or member-sponsored guests engaging in improper behavior may receive a flagged warning on their account or have their membership privileges suspended or terminated after due consideration by the Board of Directors. The Board of Directors, in its sole discretion, will interpret what is a violation of this code of conduct. Should termination occur, there will be no refund of monies paid by the member to the Escapees RV Club or any of the parks. Life members who are terminated will be refunded the remaining balance, after prorating for the used portion of their membership, at a one-year membership dues rate.

Escapees RV Club, Rainbow Parks Inc., Escapees Rainbow Parks Unlimited Inc., Escapees CARE Inc., and the SKP Co-Op parks are all separate corporations that serve Escapees members. Improper behavior by Escapees members in connection with any of these corporations, if properly documented and submitted to the Escapees Inc. Board of Directors, will be considered as if these actions were against Escapees Inc., its property or personnel.
